NOTICE FOR ELECTION OF THE AAI EXECUTIVE COMMITTEE/OFFICE BEARERS FOR THE TERM 2024-2028

In pursuance to my appointment as the Returning Officer (*RO) for the Election of the Office Bearers of the Archery Association of India (AAI) vide letter dated 3rd December, 2023 by President, AAI and General Council Meeting Notice issued by Secretary General, AAI vide Notice No.AAI/GCM/EC/Elect/2024-2028/1 dated December 19, 2023 to hold the meeting on **19th January, 2024 at Archery-Cricket Stadium, Gate No.2, DDA Yamuna Sports Complex, Surajmal Vihar, Delhi**, the undersigned is hereby notifying the Election Schedule.

The Elections of the Office Bearers of the Archery Association of India for the term of 4 years ie 2024-2028 shall be conducted as per the notification in accordance with the Constitution of the AAI, Election Bye-Laws of the AAI, and provisions of Model Election Guidelines provided under the National Sports Development Code of India (NSDCI)- 2011. The Election of the following posts will be conducted -

1. President - 1 (One)
2. Senior Vice-President - 1 (One)
3. Vice-President - 8 (Eight)
4. Secretary General - 1 (One)
5. Joint Secretary - 7 (Seven)
6. Hony.Treasurer - 1 (One)

Member State Archery Associations are directed to adhere to the deadlines mentioned above strictly. Any document received later than the stipulated date and time as mentioned above will not be entertained. Members are further directed to note the following instructions for compliance:-

- 1) All nomination forms for the Executive Committee Members' Election of the AAI, duly completed in all respects (along with self-attested copy of Aadhar Card of the candidate) should be submitted, in a sealed envelop addressed to the Returning Officer/Assistant Returning Officer to the office personally at AAI Office, Archery-Cricket Stadium, Gate No.2, DDA Yamuna Sports Complex, Delhi-110092 or via email at roaai.2024_2028@yahoo.com so as to reach it before the deadline by 05.00 PM of 07-01-2024. Nomination Form -2 for the Election of the Executive Committee of the AAI is attached.
- 2) The nomination of a candidate for election as an Office-bearer of the AAI shall be proposed by one (1) of the delegates of the State Association whose name is included in the Electoral College list in Form 1 and also subscribed by one (1) such delegate as seconder.
- 3) Each candidate shall be entitled to be nominated by not more than two(2) nomination papers.
- 4) No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder, and if he/she so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
- 5) No person shall be permitted to withdraw his/her name as proposer/seconder once the nomination paper subscribed by him/her has been delivered to the RO.
- 6) If one nomination paper of any candidate for a post is found valid, it shall be deemed to be a valid nomination.
- 7) Any validly nominated candidate can withdraw his/her nomination by submitting the Withdrawal Form-5 latest by 5.00 PM of 14-01-2024.
- 8) Notice of withdrawal of candidature shall be submitted either by the candidate himself/herself or by a person or via personal email of such candidate mentioned on the nomination form.
- 9) Notice of withdrawal of candidate shall be final and shall not be allowed to be canceled/rescinded.
- 10) The RO shall accept the notice withdrawal if he is satisfied with the genuineness of the notice.
- 11) At the time of scrutiny of nomination, each candidate or one of his/her authorized representatives shall have the right to be present and raise any objection in relation to the nomination of candidate (s) for the post for which he/she has filed his/her nomination.
- 12) Nomination papers presented will be scrutinized on a first come first serve basis and hence time for receipt of nomination papers has to be recorded on the envelope/nomination paper.
- 13) Each contesting candidate can nominate one person, if he/she desires, to be present in the Polling Station as an Observer by making a request in writing.
- 14) At the poll, each delegate whose name is included in the Electoral College list shall be entitled to cast one vote for each of the posts remaining unfilled, where only one seat is to be filled.
